BYLAW NO. 2-2011

A BYLAW OF THE DUNDURN RURAL WATER UTILITY TO AMEND BYLAW 01-2007 BEING A
BYLAW GOVERNING THE MANAGEMENT OF THE PUBLIC UTILITY BOARD

WHEREAS the Board of the Dundurn Rural Water Utility has passed Bylaw No. 01-2007 on the 9th day of June, 2007, which provides for the fixing of the rates to be charged for the use and consumption of water from the public utility waterworks along with General Business of the Board including Board Members and their Duties and Powers; and

WHEREAS it is deemed desirable that the aforesaid bylaw shall be amended;

NOW, THEREFORE, the Board of the Dundurn Rural Water Utility, in the Province of Saskatchewan, enacts as follows:

1. **THAT** Section 1, DEFINITIONS for "Public Utility Board" is amended by inserting the following words after 'R.M. of Rosedale #283':

'Resort Village of Thode Resort Village of Shields'

- 2. THAT Section 7, OTHER DUTIES OF THE BOARD is amended by:
 - a. Deleting from subsection f) the following words:'See Schedule "A" and "B" '
 - b. Inserting the following after subsection i):
 - "j.) Any unpaid balance of principal and interest owing for that year and / or water service charges as at December 31 shall be applied to the relevant property taxes, under the provision of The Municipalities Act."
- 3. THAT Section 11 is amended by deleting the following words: "The water rates charged by the Utility shall be these set forth in the attached Schedule "A" plus applicable taxes.'

And replacing them with the following words:

"The water rates charged by the Utility shall be those set forth in the bylaw of the Dundurn Rural Water Utility to fix the rates to be charged for the use and consumption of water, and any amendments thereto"

4. **THAT** Section 13 is deleted in its entirety and replace with the following:

13. UTILITY BILLING

"Utility billing will be in accordance with the bylaw of the Dundurn Rural Water Utility to fix the rates to be charged for the use and consumption of water, and any amendments thereto."

- 5. THAT Schedule "A" be repealed.
- 6. **THAT** Schedule "B" be repealed.
- 7. **THAT** the schedule attached and marked "B" shall take effect in all respects as Schedule "B" to Bylaw No. 01-2007.
- 8. THAT Bylaw 1-2011 is hereby repealed.
